

2021 ALASKA AIRLINES CLUB 49[®] LOCAL GETAWAY GIVEAWAY – OFFICIAL RULES

NO PURCHASE OR PAYMENT IS NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. DESCRIPTION

The sponsor of the Alaska Airlines Club 49[®] Local Getaway Giveaway is Alaska Airlines, Inc. (Sponsor). The Local Getaway Giveaway begins on May 11, 2021 at 6:00 a.m. AKDT and ends on July 4, 2021 at 11:59 p.m. AKDT (Promotion Period).

Once the weekly winners have been selected, following the schedule below, the entries will refresh for the new weekly prizes.
